



The Board of Assessors met at 7:45 a.m. Mr. Reardon, Mr. Laverty and Mr. Clark were present.

The Board opened the meeting to public participation for questions. Ms. Sheila Flewelling of 36 Sycamore Street joined the meeting with questions regarding traffic adjustments made for her home located at the intersection of White and Sycamore Street. Mr. Bruce Ludell of 63 Leicester Street joined the meeting questioning the value process of his home. There were no additional questions from the public.

The minutes of the previous session were read. On motion by Mr. Laverty, seconded by Mr. Reardon, passed unanimously, the minutes were accepted as read.

The Board signed the Assessors Warrant to Collector Motor Vehicle and Trailer Excise for the Eighth Commitment of 2020, in the amount of \$2,422.50.

The Board discussed the current senior tax relief exemptions available by statute and other alternatives to present tax relief to older Belmont Residents.

The board discussed hiring an intern from a local university for assistance on future projects. Additionally the board discussed further integration of GIS for deeper analysis beyond DOR Certification Requirements.

Mr. Dargon updated the Board on cyclical inspections which began on 04/27/2021 for Assessor Maps 23-28. Representatives for the Contractor JF Ryan will be inspection properties Monday through Saturday until mid-August.

The Board acted on one hundred and thirteen (113) applications for abatement of real estate and personal property taxes. Seventy five (75) were granted.*
