## History and Facts by Richard Betts

Settlement in the area that now includes Belmont began in 1630, when Sir Richard Saltonstall and approximately 40 families separated from the first settlers of the Massachusetts Bay Colony and moved inland to start an agricultural community. Originally called Pequotette after the local Indian tribe, the name of the new town soon changed to Watertown. In 1638, by order of the General Court, Watertown paid the Pequotette Indians the sum of 13 pounds, 7 shillings and 6 pence for the land. The original settlement spread inland extensively into the present towns of Watertown, Waltham, Weston, Lincoln, and parts of Cambridge and Belmont. In 1738, Waltham seceded from Watertown, and the future Belmont was now part of three towns.

In 1805, Frederick Tudor began cutting ice on Fresh Pond. As his business grew, he decided to build a railroad from his wharves in Charlestown to Fresh Pond. This line was built about 1843.

With the railroad so near, the citizens of Waltham clamored to have it extended to their village which was granted and the line ran through what was to become the Town of Belmont. The railroad made the purely agricultural community available for residences of well-to-do Bostonians. Settlements centered around Wellington Station (now Belmont Center), Waverley Station, and Hill's crossing station.

Those settlements grew into villages, but local government arrangements were annoying because citizens had to go to Watertown, Waltham, or West Cambridge (now Arlington) to vote and attend town meetings. A group of about 1,000 people joined together in the early 1850's and announced their desire to form a separate town. One of the most enthusiastic advocates was John Perkins Cushing, the largest taxpayer of the proposed town, who gave generously and openly to the incorporation expense on the condition that it be named after his 200-acre estate "Bellmont."

The towns of Watertown, Waltham, and West Cambridge fought the proposed creation of a new town, but in the end the battle was won and on March 18, 1859 the Town of Belmont was born. Of the then total area of 5 square miles, 2.26 were taken from Watertown, 0.67 from Waltham, and 2.82 from West Cambridge. The population was 1,175 of whom 170 were registered voters and 325 were school children. The new town was a widespread collection of fruit farms and market gardens. Produce from Belmont farms was sold at Faneuil Hall market. Specialties included celery, tomatoes, cucumbers, berries, and small fruits. In fact, "Belmont" became a term of distinction indicating quality and large size.

The original town included a part of present-day Cambridge including half of Fresh Pond. Because of a controversy over a slaughter house erected in Belmont on the banks of the pond which was the drinking water supply for Cambridge, 0.89 square mile of Belmont was annexed in 1880 to that city.

This left Belmont with a total area of 4.676 square miles. Minor adjustments due to various Route 2 widenings makes the total area 4.655 square miles today.

In the 1900's, the large number of artists, authors, educators, physicians, and scientists moving to the town doubled its population. As a result, the farming community disappeared. Belmont today, with a population of 25,349, is almost entirely residential and is known as "The Town of Homes."

The Town Clerk acts as the Town's chief election official, recording officer, registrar of vital records and statistics, Public Records Access Officer and licensing officer and is the point for general information to Belmont's inhabitants, the Commonwealth of Massachusetts, Federal Government and the general public.

The current Town Clerk is also commissioned by the Commonwealth of Massachusetts as a Justice of the Peace and Notary Public and serves on the Board of Registrars of Voters.

If you are new to town, stop by the Clerk's Office to complete a Belmont Census Form. The Census is a reference for the Emergency 911 system and will provide proof of your Belmont residency. Residents and their children must be listed on the Belmont Census to be enrolled in the Belmont Public School System. The Belmont Census and pet license application is mailed to all households each January.

**Register to Vote:** To register to vote in Massachusetts, you must be a citizen of the United States and be at least 18 years old on or before the next election, and a resident of Massachusetts. Pre-registration is available to US citizens age 16-17. Residents of Massachusetts can register to vote online at [www.RegisterToVoteMA.com](http://www.RegisterToVoteMA.com). You may also register to vote in person at the Town Clerk's Office or by mail; forms can be downloaded from the Town Clerk's website. Although you may have been registered to vote in another community, if you move your residence to or within Belmont, you must register to vote at your new address. Deadline to register to vote or change party enrollment is 10 days prior to next election and the Town Clerk's office is open until 5:00 pm that evening.

## **Early Voting by Mail:**



Vote by Mail Ballots must be requested in writing and the request must contain the signature of the voter requesting ballots. No ballots are simply handed out. Vote by Mail applications are valid for specific elections or yearly through December 31<sup>st</sup>, and new applications must be filed for each calendar year. The application form is available at any Town or City Clerk's

Office, online and in public libraries throughout the State. If the voter is unable to submit a form, a family member may apply for the voter.

## **Early Voting In-Person:**

In-person Early Voting is available for most elections at Town Hall. Check the [website](#) for times and dates.

*Please note: If you are an unenrolled (independent) voter, requesting a ballot for a state primary election you **must** indicate the party of the ballot you request or no ballot will be mailed to you.*

## **Birth, Marriage and Death Certificates:**



Certified copies of birth, death and marriage records may be obtained in person, by mail or online from the Town Clerk's Office. Certified copies of vital records may also be obtained at the Massachusetts Registry of Vital Records and Statistics. We suggest calling the Town Clerk's Office

to be certain that the record is available in Belmont. Certified copies of vital records are \$20.00 each. For in-person requests, cash and checks payable to Town of Belmont are acceptable forms of payment. A [mail-in order form](#) and [online form](#) are available on the Town Clerk's web pages.

### **Marriage Licenses:**



To apply for a Marriage License, both parties must appear in person together and apply at the Town Clerk's Office. Proper identification, such as a driver's license or passport is required. There is a three-day waiting period before the license may be available for use, and once obtained, is valid for 60 days from the date the intentions were filed. Marriage licenses obtained in Massachusetts allows the couple to be married in any city or town in Massachusetts.

### **Dog and Cat Licenses:**



According to Belmont General Bylaw 60-200 all dogs and cats age four months and older require a license, valid from January 1st through December 31st. Licensing must be completed no later than March 15th of each year, with exception given to new pets. A current Certificate of Rabies Vaccine and proof of spay/neuter is required. Renewal of licenses can be done [online](#). Acceptable forms of payment are Electronic Checks (EFT or e-check), debit and credit cards.

## **ANNUAL PET LICENSE FEES**

### **New Pets from January 1<sup>st</sup> to December 31<sup>st</sup>**

Neutered/Spayed: \$12 per pet; Unaltered: \$37 per pet

### **Late fees are applied for all RENEWALS received after March 15<sup>th</sup>**

Neutered/Spayed: \$24 per pet; Unaltered: \$49 per pet

Pet owners aged 60 or older may deduct \$3 from the license fee.

Failure to license pets will also result in a \$50.00 violation and requirement to license. Failure to vaccinate pets will result in a \$100 non-criminal violation (MGL Chapter 140)

Cash or check, payable to *Town of Belmont*, are acceptable forms of payment.

### **Public Records Request:**

Massachusetts Public Records laws provide access to public documents and other information. The Town of Belmont uses an [online portal](#) to streamline requests for public records. You can use this system to make requests, or to help you find previously uploaded documents. You may even find what you're looking for without submitting a new request!

## **Business Certificate / Doing Business As:**



The purpose of a Business Certificate is to disclose business ownership information. [Massachusetts General Laws, Ch.110 § 5](#) require that all businesses operating under any title other than the real name of the person conducting the business obtain a Business Certificate. A Business Certificate is not required if any corporation is doing

business under its true corporate name, nor is it required to any partnership doing business under any title which includes the true surname of any partner. The only exception is if your bank requires a Business Certificate to open a business bank account.

## **Home Based Business\*:**



In Belmont, if the business is located in your home, you must first acquire a Home Occupation Permit in person from the Office of Planning & Building. The permit is a zoning check per the [Belmont Zoning Bylaw 3.4.2](#) and is valid for four years. The price is currently \$30 and the permit must be presented to the Town Clerk's office when filing for a Business Certificate.

*\*Please note that if the residence is leased, a letter of consent is required from the landlord and must be presented to the Office of Planning & Building with the Home Occupation permit application.*

A Business Certificate is valid for four years and costs \$50, cash or check made payable to the Town of Belmont. Applicants must apply in person in the Town Clerk's office with valid photo ID and all owners of the business must be present to sign the documents. Attestation to the Social Security Number or Federal Employer ID Number (FEIN) is also required.

## **Yard Sale Permits:**



In order to hold a private sale in Belmont, you must first file for a [Private Sale Permit](#) for free. If you do not have access to the internet or email, contact the Town Clerk's office at or visit us in person for assistance.

You will receive the permit via email as soon as you submit the request for the specified date, time, and address. Private sales are limited to three per address per calendar year. If you have applied for a permit and the sale is canceled due to rain, contact the Town Clerk's office. If the database indicates that three such sales have already occurred at the address, no additional permits will be issued for the current calendar year. Please note that for Neighborhood Sales, each address must file for its own Private Sale Permit.

**Town Meeting:** Annual Town Meeting takes place in the spring, and typically lasts for six evenings, typically Mondays and Wednesdays. Town Meeting begins on the fifth Monday of April, if any, or the first Monday in May per the [General Bylaws §30-105](#).

Town Meeting makes all of the decisions about the Town's budgets and local Bylaws. Belmont's government is a Representative Town Meeting, which means that only Town Meeting Members can vote at Town Meeting, unlike the Open Town Meeting form of government. That's why it's very important that all the Town Meeting seats are filled to have full representation of each Belmont neighborhood.

For dates and times of scheduled Town Meetings, both annual and special, check the Town Clerk's [website](#).

**Running for Town Meeting Member:** Every year, Belmont holds a Local Election in which Town-wide offices as well as twelve Representative Town Meeting Members from each of our eight voting precincts are elected. The elected term for Town Meeting Member is three years; however, should a resignation occur, there may be openings for additional partial terms.

Candidates for Town Meeting Member must be at least 18 years old and a registered voter of the Town of Belmont. To have your name appear on the ballot, you must file nomination papers. Nomination papers are available in the Town Clerk's office beginning in December; have your neighbors and friends who are registered voters sign your papers and submit the signed forms to the Town Clerk by the deadline.

Signatures of at least 25 registered voters of your precinct are required on the nomination papers. The Town Clerk must certify these signatures so we always suggest obtaining about 20% more just to be safe.

Newly elected and re-elected Town Meeting Members are administered the oath of office at the first session of each Town Meeting.

**Elected Officers of the Town of Belmont:** To be considered a candidate for Town-Wide Office, you must be at least 18 years old and a registered voter of the Town of Belmont.

To have your name appear on the ballot, you must file nomination papers (see previous page). Signatures of at least 50 registered voters of the Town are required on the nomination papers. The Town Clerk must certify these signatures so we always suggest obtaining about 20% more just to be safe.

Upon election to a Town office, board or commission below, the individual must be administered the oath of office (be sworn in to serve) at the Town Clerk's Office prior to serving. At that time, the office holder will be provided a copy of the State's Open Meeting Law, Public Records Law and Ethics/Conflict of Interest Law and must submit a receipt of same.

# RECREATION DEPARTMENT

Belmont provides its residents with numerous recreation facilities and programs throughout the town, including playgrounds, outdoor tennis courts, indoor and outdoor pools, field house and fitness room at Belmont High School, ball fields and a skating rink. **Paws in the Parks:** Over the past few years, since the pandemic, the Off-Leash dog program has been the source of much conversation. In 2023, in response to a broadening conversation surrounding dogs and parks usage, the Recreation Department formed a working group of key stakeholders to discuss and work towards a fair solution. The Beech Street Center, also known as the Senior Center, houses the Council on Aging, which is charged with the responsibility of advocating on behalf of the seniors of Belmont and ensuring that their social, financial and healthcare needs are met. Services include transportation for shopping and medical needs by reservation; nutrition services, (meals on wheels and daily luncheon); social services (confidential referrals and help with concerns); programs and newsletter (cultural, educational, recreational, holiday observance, entitlement, athletic, and social). The Council on Aging has a network of appropriate resources available for Elders both in Belmont as well as outside the community.

## **BELMONT PUBLIC LIBRARY**

The Belmont Public Library has a circulating collection of books, movies, e-books, music CDs, music downloads, magazines and newspapers. Your library card also provides you direct borrowing privileges and interlibrary loan access to 36 public and 7 college libraries within the Minuteman Library Network. Reservations of museum passes are also available. The library's collection is composed of a growing number of online resources. These databases provide a wealth of resources for free, through the library's website.

*\*Due to the construction of a new library building in 2024, the library is open in temporary locations (the Beech Street Center, 266 Beech St, and the E.C. Benton Library, 75 Oakley Rd) for holds pickup only. Please check the library website for hours.*

**Trash & Recycling:** Trash, recycling, yard waste and bulk items must be placed at the curb by 7:00 am on your designated collection day. A Waste & Recycling Calendar and a list of acceptable recyclables can be found on the DPW website.

**Solid Waste Collection:** Trash is collected weekly. All regular household refuse must be bagged and placed in the black 64-gallon cart for trash collection; leave 3ft. between solid waste and recycling carts. Material may not be sticking out of the cart and lid must be fully closed. Do NOT place recyclables in the black cart. Excessive trash needs to be put in a purchased overflow bag and placed next to the cart.

**Bulky Items:** A single bulky item such that does not fit in the cart may be disposed of by calling Waste Management at (800) 972-4545 by 1pm the day prior to scheduled trash collection.

**Mattresses / Box Springs:** Mattresses and box springs must be scheduled for pick-up in advance by calling (617) 993-2680.

**Recycling** is collected every other week. Use the 96-gallon cart with blue or green lid for all acceptable recyclables.

**Recycling Stickers:** Stickers cost \$25.00 per appliance. Call the Highway Division office at (617) 993-2690 by 11:00 am on Friday to schedule a pick-up for the next available Tuesday. Stickers may be purchased at the DPW office, Town Clerk's office, Star Market, Winters Hardware, and Hillside Garden Supply in Belmont.

**Yard Waste:** Spring Yard waste is collected on your recycling day starting April 1<sup>st</sup>. Yard waste must be placed curbside in 32-gallon trash containers, marked with two Yard Waste stickers provided by the town or be placed in 30-gallon brown paper biodegradable bags, no plastic bags accepted. Containers may not exceed 50 lbs. in weight. For fall leaf collection, collection of leaves will be EVERY week on your regular rubbish day between October 22nd and December 6th.

Christmas trees will be collected the first two full weeks of January.

**The Highway Division** repairs, patches, maintains, cleans, signs and paints crosswalks, center and parking lines on Belmont's 77.76 miles of public ways, 8.28 miles of private ways and 97 miles of paved sidewalks. All public and private roads are cleared and treated during snow and ice conditions. Additionally, the Highway Division is responsible for the maintenance of the sanitary & stormwater sewers and construction of new storm drains. Under the direction of the Tree Warden, the DPW contracts with a tree service company to care for, remove, and replant the 10,000 or so public shade trees. The Highway Division is responsible for the cleaning, planting, mowing and maintenance of 52 separate deltas, islands and public spaces totalling about 53 acres. The Division is also responsible for the collection of solid waste & recycling for the 10,000 residential households and public buildings. **The Parks and Cemetery Division:** Parks provides for the cleaning, mowing, maintenance, repair and improvement of the resources for school athletics and recreational enjoyment for 62 acres of athletic fields, parks, tennis courts, basketball courts and tot lots including the operation of the new future skating rink & athletic facility and Underwood Pool.

The administration of the Belmont Cemetery is governed by the obligations created by [M.G.L. Chapter 114](#). Responsibilities include cleaning, mowing, maintenance, repair and improvement of two cemeteries totalling 24 acres. In addition, staff provides a wide variety of services including selling grave lots, meeting grieving families' needs, coordinating with funeral homes, interments and providing information for the general public.

**The Engineering Division** provides information on sanitary sewers and storm drains and is the keeper of records of house plans and street layouts. The Engineering Division is responsible for the development, design, and construction oversight of all major roadway construction under the Pavement Management Program. The Division is also responsible for the development, design, and construction oversight of all major sanitary sewer and storm drain rehabilitation projects. The Engineering Division also provides technical assistance with other special projects.

**The Building Division** oversees and inspects all building construction within the Town. Any building work beyond the scope of ordinary repair requires a building permit. These construction activities are regulated by the Massachusetts State Building Code. The Code is enforced and interpreted in Belmont by the Inspector of Buildings.

**The Plumbing and Gas Division:** The Plumbing and Gas Inspector office hours are Monday to Thursday from 12:30 - 1:30 pm. He is available during that time to answer questions or schedule inspections. Inspections are conducted following office hours between 1:30 - 5:30 pm Monday to Thursday.

**The Planning Division** provides professional "in-house" planning services to the Town offering guidance on land use issues to the Select Board and the Town Administrator. The Division staffs the Planning Board and Zoning Board of Appeals, and other temporary land use study committees established by the Town. The Division represents the Town at regional and state meetings involving land use matters. The Division also works closely with other town departments seeking grants for historic preservation, affordable housing, open space, and transportation.

The Town Treasurer/Collector's office is responsible for collecting all taxes and committed bills issued by the Town and for the receipt, posting, classifying, depositing and investment of all money belonging to the Town. Other responsibilities include administration of Tax Title and Foreclosure accounts, Debt Service, Trust Funds, Investments and bank account reconciliations.

**Real Estate and Personal Property Tax** for the fiscal Year (July to June) are mailed the middle to last week of June, September, December and March. Payments are due by 4 pm in the Tax Collector's office on August 1, November 1st, February 1st and May 1st or the following regular business day if the 1st falls on a weekend.

**Motor Vehicle Excise Tax**, although collected by the Town, are generated from the records of the Registry of Motor Vehicles as of January 1st of the bill year.

**Parking Clerk:** The Parking Clerk is appointed by the Select Board. Payments for violations may be made at the Treasurer's office and are due within 21 days after the violation was written to avoid added fees and possible non-renewable status at the Registry of Motor Vehicles. If you wish to contest a violation, you must do so in writing using the form on the Parking Clerk's [webpage](#).

Residents may pay online, by mail or drop off tax payments\* or parking violation payments to the Treasurer's Office or in the payment box located outside 19 Moore Street, to the left of the entrance.

*\*All payments for water and electricity should now be made at the Belmont Light office located at 40 Prince St.*

## HEALTH DEPARTMENT

The Health Department provides an array of services under the general heading of disease prevention and health promotion. This includes, but is not limited to, all of the inspectional services for all food services, swimming pools, day camps, tobacco sales, Smoke Free Workplace laws, subsurface sewerage systems, sanitary housing, dumpsters, mercury recovery program, rechargeable battery collection and Childhood Lead Poisoning Prevention, body art, biotechnology and emergency preparedness, communicable disease follow up and West Nile Virus monitoring.

**Animal Control Officer:** The Animal Control Officer is a part of the Town of Belmont's Health Department and provides Animal Control services to the community. The Town Administrator serves as the Chief Administrative Officer of the Town and has three primary responsibilities:

1. Directs and manages the delivery of municipal services, with the exception of those under the jurisdiction of the independently elected authorities;
2. Provides leadership to the Select Board for strategic planning; and,
3. Serves as the Director of the Office of the Select Board.

The Town Administrator's Office is responsible for the preparation of the annual operating and capital budgets, which integrates the work of appointed citizen committees, such as the Warrant Committee, Capital Budget Committee, to ensure involvement in the budget decision-making process. The Office also works collaboratively with the School Committee and School Administration to assist in the development of the School Department Budget.

Other responsibilities include: Responding to questions and concerns of residents; Advising and recommending to the Select Board members those needs, policies, programs and actions deemed necessary or expedient for the effective operation of Town government; Acting as the Select Board's agent to negotiate collective bargaining agreements for Town labor units; Serving as a liaison with State, Federal and regional governmental organizations, local business and community leaders and the general public; Coordinating Town Counsel services to respond to legal matters and to prepare the official Town Warrant and documentation for Town Meeting; Publishing the Annual Town Report; And, directing town functions on the behalf of the Select Board, such as: granting licenses, setting fees, and coordinating temporary and permanent volunteer committees and task forces to address Town issues.

**By Subway train:** Alewife station, the end of the Red line, is about 1.5 miles from Belmont Center, where Route 2 crosses into Cambridge from Arlington.

**By Bus:** There are several routes to and through town.

ROUTE 73, which runs from Harvard Square (Cambridge), up Mt Auburn St, to Belmont St, to Trapelo Rd, to Waverley Square.

ROUTE 74, which runs from Harvard Square (Cambridge), up Concord Ave, down Blanchard (south), back to Concord Ave, past the Middle & High School and to Belmont Center.

ROUTE 78, which runs from Harvard Square (Cambridge), up Concord Ave, up Blanchard (north), to Pleasant St at Route 2, up Route 2, then into Arlington.

ROUTE 84 and Route 76 and Route 62, which run from Alewife along Route 2, then veer off to Arlington or Lexington.

ROUTE 554, which runs from Roberts/Brandeis to Waverley Square, to Central Square (Waltham), to Newton Corner, and Downtown Boston.

**By Commuter Rail:** There are two rail stops in Belmont, Belmont Center and Waverley Square, both on the Fitchburg to North Station, Boston line.

Be sure to check the MBTA website for maps, schedules, service changes and fees.

**CharlieCards** are reusable cards that can be loaded with cash value or passes to pay bus and subway fares. CharlieCards are available at fare vending machines in most subway stations. The CharlieCard works best for frequent subway and bus riders, however is not valid on the Commuter Rail or Ferry, except for the Fairmount Line.

If you don't have a CharlieCard, you can also pay your fare with:

- CharlieTicket, a tappable ticket that can be loaded with subway, bus, Commuter Rail, and ferry tickets or passes
- mTicket, an Android and iPhone app for Commuter Rail and ferry tickets or passes
- Cash at onboard fare boxes on buses and trolleys at street-level stops


