**1. Meeting was Called to Order at 7:04 PM**

**2. Approval of the September 12 Meeting Minutes**

**4. Continued Discussions**

**a. MBTA Communities Zoning Districts and Historic Preservation**

Gabe Distler gave a brief introduction, explained various maps, and said the focus should be on district boundaries as related to historic preservation. A lengthy, detailed, and wide-ranging discussion followed about Waverley Square, Cushing Square, Belmont Center, a small area of Pleasant Street north of the Brighton Street intersection, and other possible locations. Much brainstorming, and a lot of questions about zoning, tax benefits and density bonuses for preservation of significant historical buildings, compliance requirements, and MBTA deadlines. The HDC reviewed historically significant buildings that may be located within or near higher density districts and discussed the possible impact of the new zoning on the preservation of these buildings. Carl volunteered to summarize the HDC's concerns in a letter that would be transmitted to the MBTA Zoning committee. Jacqueline Appel asked what other communities have done? Gabe Distler said that Lexington was the first to submit a compliant plan. Drew Nealon, the HDC member of Belmont's MBTA Communities Advisory Committee, invited us to the next meeting, October 19, at 5:30 PM, in the Homer Building Art Gallery.

**b. Design Guidelines Subcommittee**

**f. Landmark Designation Discussion**

Drew Nealon made some brief comments.

**g. Work Plan**

Carol Moyles said that it had all been covered but emphasized the importance of the design guidelines, which needed work.

Gabe Distler reported that Jeffrey North from the Belmont Citizens Forum has asked about the HDC providing articles on various subjects. Gabe said that he will be taking some time off in November. Carol Moyles suggested adding the workplan to the regular agenda.
