- **Updated COVID-19 Guidance:**

The Select Board, in accordance with the recommendations of the Belmont Board of Health, has voted to rescind the Town of Belmont's mask mandate as of 12:01 AM on March 8, 2022. Town of Belmont Public Buildings will remain mask friendly and it is strongly recommended that unvaccinated individuals continue wearing a mask in public indoor spaces. Town of Belmont Committee and Board meetings, including the Select Board, will continue to meet in a remote capacity.

Additionally, the Belmont Fire Department would like to thank Governor Baker, Lt. Governor Polito, and Fire Marshal Ostroskey for the recent award of over \$8,100 in funds for the Student Awareness of Fire Education (SAFE) and Senior SAFE programs delivered by Belmont Fire Department instructors. The SAFE program teaches students to recognize the dangers of fire, and the hazards of tobacco products using 23 key fire safety behaviors. The Senior Safe program addresses fire safety, home safety and risk factors for older adults.
