Elizabeth Dionne called the meeting to order at 5:00 PM.

<u>Tennis Court Expansion – Winn Brook (Revised Amount \$190,000)</u>

Adam gave an update. The Select Board unanimously voted to reduce the tennis court expansion amount from \$269,750 to \$190,000. The Select Board unanimously approved all CPA projects going before Town Meeting.

Jon Marshall gave an update. Activitas gave a revised cost of \$190,000 for one tennis court. The Recreation Commission voted unanimously to add one tennis court. The changes are as follows:

- New construction cost \$130,000
- Design, Engineering, Permitting, and Project Administration \$34,000
- Contingency \$26,000
- Total Revised Request \$190,000

Margaret asked whether the projected cost included engineering work to reconfigure the drainage for the Second Soccer field that will be lost. Jon stated it does include engineering work and drainage. Elizabeth asked whether the amount requested is enough to do the work. Jon stated he is comfortable with the budgeted amount as requested to cover the work that needs to get done. Andy stated that the design and engineering fee at best is about 10% to 15%. The design, engineering, and project administration fee seems excess for \$130,000 or 26%.

Margaret asked whether the construction will begin this fall and whether the tennis court will be ready for spring of next year. Jon stated as long as we get going in September due to weather we should be in good shape.

Andy moved to recommend favorable action at Town Meeting for the Tennis Court Expansion – Winn Brook project, passed 8-1 (Margaret Velie opposed). Second by David.

Recreation Commission Update

David gave an update. The Recreation Commission reviewed their assets. There are four potential projects under consideration. They are Payson Park, Underwood Playground, Chenery Playground, and Harris Field (West). The use of administration funds could pay for the recreation master plan such as summary of existing conditions, identification of code and compliance issues, needs assessments, public outreach, site improvement, develop phase and implementation strategy. The estimate cost would be about \$30K to \$35K. A basic condition report will get you an audit report of condition sampling and materials of equipment around the town.
