Paul Roberts introduced the town's cyber incident response (IR) plan item. At the last meeting Phil Lawrence volunteered to follow up with Dave Petto and Patrice Garvin and sent an email asking for an update. Dave Petto replied that a vendor, NuHarbor, has been selected to help write the plan. Paul plans to follow up with Dave Petto to get some detail about the expected scope of the NuHarbor deliverable. ITAC hopes that it will cover the whole town, including schools, first responders, and light department. Paul will try to get ahold of the NuHarbor proposal and have Dave Petto attend our November meeting to discuss it.

Paul Roberts introduced the topic of attending an upcoming Belmont Municipal Light Board meeting on the week of November 6. It looks like four of us can make it either Thursday the 9th or Monday the 6th, both at 8AM. Paul will offer those dates to Craig Spinale and get a meeting scheduled.

Paul Roberts introduced the topic of his discussion with the Belmont Public Library prior to the last meeting related to how ITAC might help with a grant program. There is nothing new to report this meeting. Jim Berets noted that there is a plan to include Electric Vehicle (EV) chargers at the new library. Jonathan Birge noted that some of the EV chargers installed in the town don't work very well. Since the Library has indicated to us that they intend to install EV chargers as part of the new building that they should give some consideration to how they decide what to have installed. It's been a while since ITAC met with the Library staff and building committee so Paul will contact Peter Struzziero and set up another meeting.

Paul Roberts introduced the need for a new ITAC chair as he is stepping down. Dan Ellard had offered to co-chair if another of us will join him in that role. Paul suggested that we instead set up a one year rotation for chairmanship. Jonathan Green suggested two years would offer more continuity. Dan Ellard noted that the timing should be considered as it would be difficult to hand a new chair the responsibility of filing our annual report. Dave Goldberg indicated that he is open to co-chairing with Dan. Paul Roberts moves to appoint Dave Goldberg a co-chair of the ITAC.
