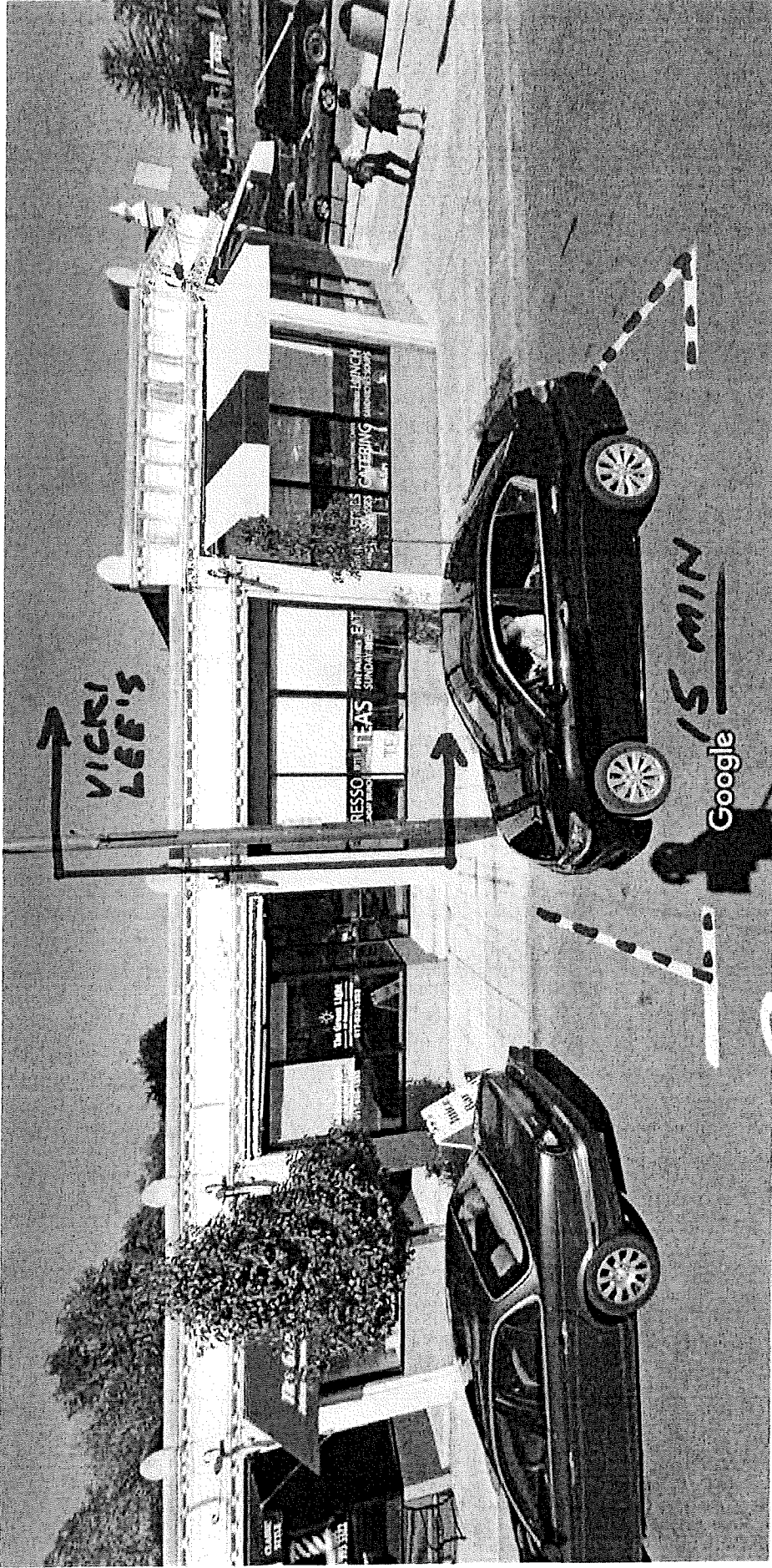

Street View - Oct 2017

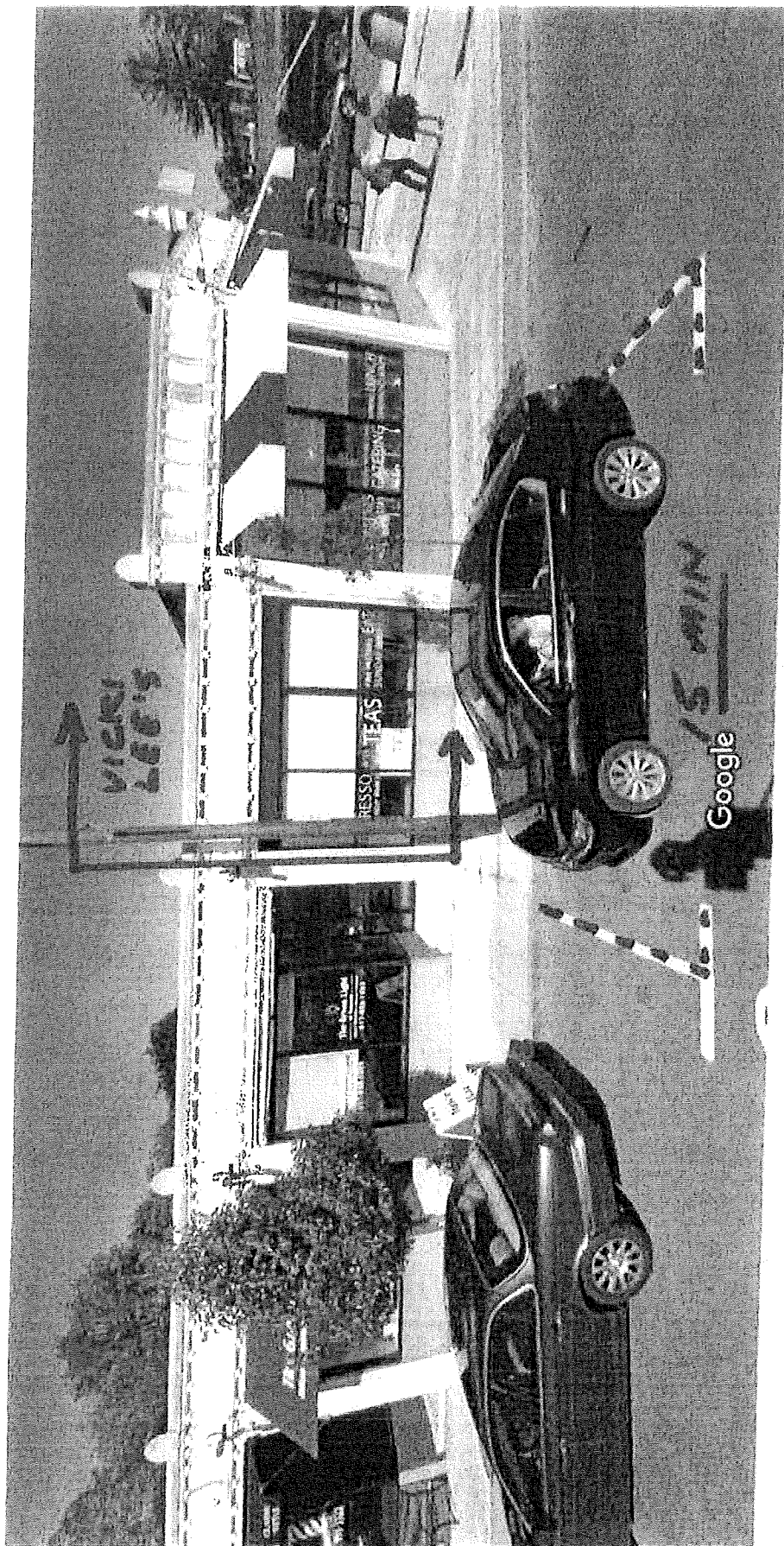




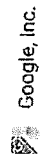
